End of the year giving just got easier!!

Are you thinking about donating to the Parish or Academy, and want to take advantage of the tax laws surrounding the gifting of securities? Well, you're in luck!

Donating stock to the Diocese of Orlando for your **Parish** or **School** via electronic transfer from your brokerage account is the *fastest* and *easiest* way to give stock donations, and it only takes 2 steps!

1. Write or phone your broker authorizing him/her to transfer "x" number of "xxx security" in kind to our Fidelity Invests account:
 - The Diocese of Orlando
 - DTC #0226
 - Acct. # X62-097373
 - Federal Employer Identification # 59-1215378
2. You or your broker call Susan Hunt so that she can identify the stock as coming from you and acknowledge you for tax purposes, and tell her the parish/school that is to be the beneficiary, and the fund that the proceeds should benefit (e.g., offertory, building, school, Our Catholic Appeal, etc.)
